HDFC account # to be captured well

1. Check Salary Slips, Should qualify card level income criteria excluding - "Bonus, Incentive, Special Allowance, Over Time, Any Variable Componant , Arrers"
2. If no deduction found in Salary Slips - Company stamp is a MUST on Salary Slips.
3. Check Salary credits in Bank Statement - Should be NEFT Only, IMPS Salary is not acceptable!
4. Salary through cheque will ONLY be acceptable if it's an Account Cheque with Company's Narration. Self Cheque Not acceptable!

1. HDFC CASA is Mandatory.
2. Home and Shop/Office addresses should not be exactly same. They can be different floors in the same house/building.

Company Identification Documents List/Mailing Address Proof List

1. Company ID Card.
2. Employment Declaration on Company Letter Head - One statement letter with Customer's Name , Emp ID, Customer Designation, and DOJ mentioned, Should also be stamped.
3. Visiting Card - Should have Customer's Name, Office Address and Official Email id.
